Questions Parents Ask: TUITION

- What is your annual tuition, and what does it include? What is not included?
Moreau Catholic has an all-inclusive tuition model, which covers: MacBook Laptop (yours to keep after the first year), textbooks and e-resources, student retreats, class fee, yearbook, and participation in athletics. The tuition for 2018-19 is \$18,650.

- What other expenses should I anticipate for my child's education at your school, including mandatory contributions?
We have an annual Booster Membership Fee of \$250 per student, which includes a tax-deductible contribution of \$150, as well as, a family membership for four and welcome packet.

- What is the deadline for need based scholarship applications?
*You must **submit** your FACTS application and all supporting documents by February 1, 2019. Please do not wait to receive your W-2 before you submit your application. Please submit by the deadline and upload your W-2 as soon as you receive it. Tax documents required are from the prior year.*

- How does my child apply for merit scholarships, and what is the deadline?
At Moreau Catholic, all freshmen applicants are considered for merit scholarships. There is no application. The Scholarship Committee will consider your admissions essays, extra-curricular activities, interview teacher recommendations, grades, and test scores when making scholarship decisions.
